GENERAL PRICE LIST

These prices are effective January 1, 2012, but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff\$1250

Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits; placement of death notices; planning of funeral arrangements; and coordination of service with cemetery, crematory, vault company and others, as required. Also included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, and administrative costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.)

Table listing various services and their prices: Surcharge for expedited service (\$150), Insurance assignment processing (\$125), Death certificate correction/reorder (after 90 days) (\$25), Mailing (priority, confirmed) of death certificates (\$15), Mailing (registered) of cremated remains (incl. container, within continental U.S.) (\$75), Storage of cremated remains beyond 120 days (\$30/month), Scattering cremated remains (time and place determined by RAPP) (\$95).

MEMORIAL CEREMONY ALTERNATIVES

Note: A \$100 surcharge will apply for an event on Sunday or holiday or beginning after 5 p.m.

Visitation, Wake, or Viewing

(may or may not precede any of the services below):

Visitation at RAPP (one day, up to 2 hours) **\$325**

This fee includes use of the facility and staff services. Each additional hour is \$50.

Visitation at other location (home, church, crematory, etc.) (one day, up to 2 hours)..... **\$300**

This charge is for staff services. Each additional hour is \$75. In addition, the facility may charge a rental fee.

Personal identification at RAPP (up to 10 people for 10 minutes) **\$95**

This charge includes use of the facility.

Funeral Ceremony (up to 2 hours):

Ceremony at RAPP **\$375**

Each additional hour is \$50. This fee includes use of the facility and staff services.

Ceremony at RAPP (same day as visitation at RAPP)..... **\$150**

Ceremony at other location (church, hall, etc.) **\$330**

This charge is for staff services. Each additional hour is \$75. In addition, the facility may charge a rental fee.

Ceremony at other location (same day as visitation at same location) **\$195**

Committal ceremony (at cemetery) following funeral ceremony **\$135**

Ceremony at Chesapeake Crematory (up to 1 hour, plus facility fee) **\$165**

Graveside Service (without prior ceremony elsewhere) **\$250**

This charge includes the services of a funeral director. In addition, the cemetery will charge its own fees.

Memorial Service (without the body present, up to 2 hours):

Memorial Service at RAPP **\$395**

Memorial service at other location **\$295**

This charge is for staff services. In addition, the facility may charge a rental fee.

TRANSPORTATION

Each charge below includes the services of a driver and vehicle expenses.

All vehicles: Surcharge of \$2 per mile, plus tolls, above 50 miles roundtrip. Surcharge of \$90 if extra staff is required.

PREPARATION OF THE BODY

EMBALMING **\$585**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

ALTERNATIVE SERVICE PACKAGES (without ceremonies)

Please note: No visitation (other than a personal identification) or service with the body (other than a graveside service) may be added to any of the selections below.

Direct Cremation.....\$910 to \$10,360

A direct cremation is one without any gathering with the body other than an identification. Our charge for direct cremation includes basic services of funeral director and staff, transfer of remains from local place of death in Maryland and to the crematory, filing of the death certificate, and a simple temporary container for the cremated remains. **It does not include the crematory fee (normally \$185) or the transfer surcharge and Medical Examiner Cremation Approval, both required if the death occurs in the District of Columbia or Virginia.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are wood or fiberboard boxes. **RAPP does not require the purchase of a container for direct cremation.**

- Direct cremation without container or with container provided by purchaser **\$910**
- Direct cremation with cardboard container (no interior) selected from RAPP **\$960**
- Direct cremation with cloth-covered corrugated casket with crepe interior from RAPP **\$1455**
- Direct cremation with alternative container from RAPP (in addition to cost of container) ... **\$910**

Immediate Burial.....\$1435 to \$10,885

An immediate burial is one without any prior viewing or service. (A graveside service may be added.) Our charge for this service includes the transfer of remains from local place of death in Maryland, basic services of funeral director and staff, casketing, and transfer of body to local cemetery by van. **This charge does not include an outer burial container or cemetery fees.**

- Immediate burial with casket provided by purchaser **\$1435**
- Immediate burial with flat cloth-covered corrugated casket with crepe interior **\$2300**
- Immediate burial with other casket selected from RAPP (in addition to cost of casket) **\$1435**

Forwarding Remains to Another Funeral Home \$1595

This charge includes local removal of remains, basic services of staff, embalming, and transportation to BWI or DCA airports. This charge does not include the container, a visitation, or a ceremony. (You may add dressing, casketing, cosmetics, and the casket of your choice. For international shipping, additional fees will apply.)

Receiving Remains from Another Funeral Home \$1195

This charge includes transportation from either BWI or DCA airports, basic services of staff, temporary shelter of remains, and transportation of remains to local cemetery or crematory. This charge does not include visitation or ceremony. (You may add a graveside service only.)

Below are some common service totals for cremation; there are many other possible combinations. For each listed here, certified death certificates, hairstyling, urn, and memorial items are extra. In addition, a \$80 charge applies if a separate trip is required to secure the death certificate. In addition, a \$90 surcharge applies if extra personnel is required, and a \$100 surcharge applies if the death occurs in Virginia, Delaware, or the District of Columbia.

Minimum Cremation \$1095

Direct cremation (services of staff, transfer of body from local Maryland place of death and to crematory) (\$910), identification of the deceased by photo or at home or nursing home, crematory fee (\$185).

Personal Identification and Cremation \$1290

Direct cremation (services of staff, transfer of body from local Maryland place of death and to crematory; \$910), preparation for identification (\$100), personal identification of the deceased at RAPP (\$95), crematory fee (\$185). (You may add an alternative container for \$50 to \$9450.)

You may not add a viewing or funeral to the above two plans. You may add any service or merchandise to those below.

Cremation with Service at Crematory \$3195

Basic services of funeral director and staff (\$1250), transfer of body from local place of death and to crematory (\$480), bathing and disinfecting (\$250), dressing (\$85), casketing (\$50), cloth-covered fiberboard casket with crepe interior (Harmony, \$545), one-hour gathering at crematory (\$165 staff + \$185 facility), crematory fee (\$185).

Limited Family Viewing and Cremation \$3350

Basic services of funeral director and staff (\$1250), transfer of body from local place of death and to crematory (\$480), bathing and disinfecting (\$250), dressing (\$85), casketing (\$50), cosmetics (\$50), two-hour visitation at RAPP (\$325), flannel-covered corrugated casket with crepe interior (Kinsman, \$675), crematory fee (\$185).

Traditional Cremation \$3960

Basic services of funeral director and staff (\$1250), transfer of body from local place of death and to crematory (\$480), embalming (\$585), dressing (\$85), casketing (\$50), cosmetics (\$50), two-hour visitation at RAPP (\$325), solid wood rental casket with crepe interior (\$950), crematory fee (\$185). (No funeral ceremony included.)

Church Funeral and Cremation \$4890

Basic services of funeral director and staff (\$1250), transfer of body from local place of death (\$295), embalming (\$585), dressing (\$85), casketing (\$50), cosmetics (\$50), hearse to church (\$345), funeral in church (\$330), laminated fiberwood cremation casket with crepe interior (Longkay, \$1715), crematory fee (\$185).

COMPLETE SERVICE PLANS: BURIAL

Listed below are some common service totals for burial; there are many other combinations. For each listed here, hairstyling, memorial items, vault or liner, cemetery fees, and clergy/church fees are extra. In addition, a \$80 charge applies if a separate trip is required to secure the death certificate. In addition, a \$90 surcharge applies if extra personnel is required, and a \$100 surcharge applies if the death occurs in Virginia, Delaware, or the District of Columbia.

Immediate Burial (No Service)..... \$2030

Immediate burial (services of staff, transfer of the body from local place of death and to local cemetery by van, casketing; \$1435), unfinished pine box with no interior (\$595). (No preparation of the body, visitation, or service.)

Immediate Burial with Hearse & Graveside Service..... \$2710

Immediate burial (services of staff, transfer of the body from local place of death and to local cemetery, casketing; \$1435), hearse (\$160), staff direction of graveside service (\$250), cloth-covered corrugated casket with crepe interior (M-flare, \$865). (No preparation of the body or visitation.)

You may not add a viewing or funeral to the above two plans. You may add any service or merchandise to those below.

Viewing and Graveside Service \$4630

Basic services of funeral director and staff (\$1250), transfer of the body from local place of death (\$295), embalming (\$585), dressing (\$85), casketing (\$50), cosmetics (\$50), 2-hour visitation at RAPP (\$325), hearse to local cemetery (\$345), staff direction of graveside service (\$250), non-warranted 20 gauge steel casket with crepe interior (Winston Plain or Trindex, \$1395).

Church Viewing and Funeral \$4935

Basic services of funeral director and staff (\$1250), transfer of the body from local place of death (\$295), embalming (\$585), dressing (\$85), casketing (\$50), cosmetics (\$50), same-day visitation and funeral service in church (\$495), committal service (\$135), hearse to local church & cemetery (\$345), non-warranted 20 gauge steel casket with crepe interior (Bradbury, \$1645) or fiberboard casket with crepe interior (Heritage, \$1645).

Deluxe Viewing and Funeral \$5860

Basic services of funeral director and staff (\$1250), transfer of the body from local place of death (\$295), embalming (\$585), dressing (\$85), casketing (\$50), cosmetics (\$50), 4-hour visitation at RAPP (\$425), funeral service in church (\$330), committal service (\$135), hearse and limousine to local cemetery (\$740), warranted 20 gauge steel casket with crepe interior (Hartley, \$1915).

OUR PRICE GUARANTEE

RAPP will match any price for an identical service package, casket, or urn listed on a current price list published by any retail funeral service or merchandise provider within 25 miles of RAPP. The service and/or merchandise must be listed on RAPP's General Price List, Casket Price List, Outer Burial Container Price List, or Urn Price List.

RAPP offers *free* delivery of caskets to any funeral home and of outer burial containers to any cemetery within 25 miles of RAPP.

PAYMENT AND CREDIT TERMS

Rapp Funeral and Cremation Services (RAPP) provides this information to all clients so they are fully informed of their payment and credit rights and responsibilities. These policies are essential to maintaining the low prices that benefit all RAPP clients.

Payment in full is due at the time of contract signing.

RAPP accepts the following forms of payment:

- Cash, money order, cashier's check, or certified check;
- Transaction authorized by Visa, MasterCard, or Discover;
- Personal check (with proper identification, date of birth, and social security number). A \$25 fee will apply for each dishonored check.

In lieu of payment in full at the contract signing, RAPP may, at its sole discretion, accept proof of eligibility for and signed assignment to RAPP of certain benefits (e.g. life insurance). If the assigned benefits paid are not sufficient to cover RAPP's charges, the buyer will be responsible for the balance due.

Estates: RAPP does not invoice estates unless the attorney signs the funeral contract. You are encouraged to apply for reimbursement from the estate if one is established.

Cash Advances: RAPP contracts may include cash advances (items paid by RAPP to others on your behalf). Some cash advances listed (e.g. airline and consulate charges) are best estimates only; the buyer is responsible for paying the actual, documented cash advances incurred by RAPP for the buyer.

Addendum: GREEN BURIAL

Rapp Funeral and Cremation Services is one of a select number of funeral establishments that provide green funeral services, and meet the criteria of the Green Burial Council, a tax-exempt, nonprofit organization working to encourage environmental sustainability in funeral service. Our Green Burial plans allow for a funeral to take place without the use of toxic or non-biodegradable materials or chemicals.

Each of our Green Burial plans includes our services for body preparation, storage for up to 48 hours, local transportation, and the preparation and filing of necessary documentation, permits and certificates. Each also includes a green burial container (a biodegradable casket and/or shroud). In addition, a \$80 charge applies if a separate trip is required to secure the death certificate. Further, a \$90 surcharge applies if extra personnel is required, and a \$100 surcharge applies if the death occurs in Virginia, Delaware, or the District of Columbia.

Green Options for Preparation of the Body (all using eco-friendly chemicals only):

Eco-friendly bathing and disinfecting (including aspiration as needed)	\$250
Eco-friendly light embalming (non-arterial embalming and aspiration)	\$395
Eco-friendly arterial embalming (with aspiration)	\$585
Dressing or shrouding (available only after bathing or embalming)	\$ 85

Immediate burial (services of staff, transfer of the body from local place of death and to local cemetery by van, casketing; \$1435), eco-friendly bathing and disinfecting (\$250), dressing or shrouding (\$85), biodegradable cotton burial shroud (\$175). (No visitation or service.)

Green Immediate Burial with Hearse & Graveside Service **\$3030**

Immediate burial (services of staff, transfer of the body from local place of death and to local cemetery, casketing; \$1435), eco-friendly bathing and disinfecting (\$250), dressing or shrouding (\$85), hearse (\$160), staff direction of graveside service (\$250), biodegradable cotton burial shroud (\$175), unfinished pine box with no interior (341), modified to include absorbent barrier (\$675). (No visitation.)

You may not add a viewing or funeral to the above two plans. You may add any green service or merchandise to those below.

Green Viewing and Graveside Service **\$4530**

Basic services of funeral director and staff (\$1250), transfer of the body from local place of death (\$295), eco-friendly light embalming (\$395), dressing or shrouding (\$85), casketing (\$50), 2-hour visitation at RAPP (\$325), hearse (\$345), staff direction of graveside service (\$250), biodegradable cotton burial shroud (\$175), unfinished solid pine casket with no interior (324 Jamin, \$1360).

Green Remote Viewing and Funeral **\$5675**

Basic services (\$1250), transfer of the body from local place of death (\$295), eco-friendly arterial embalming (\$585), dressing or shrouding (\$85), casketing (\$50), same-day visitation and funeral service in residence/church/etc. (\$495), committal service (\$135), hearse to local cemetery (\$345), biodegradable cotton burial shroud (\$175), unfinished solid poplar casket with crepe interior (411 Dan White, \$2260).

Green Deluxe Viewing and Funeral **\$7215**

Basic services (\$1250), transfer of the body from local place of death (\$295), eco-friendly arterial embalming (\$585), dressing or shrouding (\$85), casketing (\$50), four-hour visitation at RAPP (\$425), funeral service in church (\$330), committal service (\$135), hearse and limousine to local cemetery (\$740), biodegradable cotton burial shroud (\$175), unfinished solid pine casket (M2PAP White, \$3145).
